A tutor, formally also a tutor and lecturer, both teach; they are two completely different positions. A tutor can teach anything outside of school. Tutors can have very specific skill sets that they teach to their students. Tutors are often teachers in one subject or two. They work privately for single or small groups of students.

- **Feedback and attention** tutors are more able to provide detailed, immediate feedback and give more attention to individual students; <u>Find A Tutor</u>

Teachers and lecturers are required to obtain a certificate or a college degree and usually follow one size fit it all approach to classroom learning. A tutor may be more flexible and choose a method of teaching that adapts to an individual student's needs and learning situation.

Usually, teachers need to provide additional learning material for students as there is not enough time during the lesson. The tutor tends to provide individual support when it is required and facilitate and clarify what has been done in the classroom. In addition, a tutor can help students improve their study skills and strategies.

3. Roles and duties of teachers and tutors

Robert Lado(1964) explains the teacher's role by saying that when a better way to teach something is reported, the teacher incorporates it into his courses, just as a physician incorporates into his practice new and more effective ways of treating each disease as reported in the medical literature.

The basic role and function of teachers are to help students learn and gain knowledge by putting them in a real learning situation in which students can learn efficiently. As a matter of fact, the roles and duties of teachers differ from one society to another and from one educational level to another. Thus, the roles can be performed in the school, community or university.

The teacher or lecturer is expected to be a facilitator, leader, educator, artist, mediator of learning, disciplinarian or controller of student behavior. They are to lead their students to the gate of knowledge and benefit from the important role of education, which is supposed to be reflected in their behaviors and their attitudes.

According to *Dewey*(1938), a teacher's work is thus "moral" because educators are charged with the fraught task of interfering in the incidental nature of most social learning. 3.2 The Basic Role of a Teacher.

- Leads and supervises a large class of students.
- Deliver the curriculum as prescribed by the ministry of education.
- Uses teaching methods and strategies that help students in the learning process.
- Keeps stick to the school hours and timetable.
- Manages behavior in the classroom and encourages students to be polite and decent.
- Delivers learning in a suitable way for all students putting regard to the individual differences among them.

3.3 A Good Teacher(Lecturer) is supposed to be:

- An excellent Communicator.
- A Good Listener to his students.
- Collaborative.
- A facilitator.
- An engineer and subject expert.
- Sympathetic.
- Patient.
- Knowledgeable and competent.
- Motivator

Jeremy (2001:P20) explains that" Teachers are not, however, ultimately responsible for their students' motivation. They can only encourage by word or deed. Real motivation comes from within each individual."

3.4 The Role of a Tutor

- Tutor individually or a small group of students.
- To introduce a relation between what is taught inside the classroom with the taught curriculum.
- Make the educational hours more suitable, accompanied by modern teaching techniques and visual aids to help learners understand the taught material.
- Bridge the missing gaps in knowledge or learning techniques.
- Help students to think profoundly and obtain new skills to help them in their life.
- Introduce a more suitable timetable to students.
- Encourage the students to learn without total dependence on the teacher.

To be successful as a lecturer, you should demonstrate superior listening and communication skills. Outstanding candidates are able to prepare and deliver powerful lectures and should be willing to collaborate with professionals in and outside of their environments.

According to the **Better Team** site, the responsibilities of a lecturer are divided into the following points:

- Preparing and delivering lectures, tutorials, workshops, and seminars.
- Developing curricula and course material that can be used across a number of platforms.
- Collaborating with other academics and lecturers to improve teaching methods and expand the knowledge base.
- Setting and grading assignments, tests, and exams.

- Attending and participating in meetings, conferences, and other events in and outside of the institution.
- Participating in training opportunities and initiatives at the institution.
- Providing support to students and other colleagues.
- Staying current by reading widely and producing published work in the field.

- Flexibility, resilience, and willingness to work long hours.
