# Digitalization of Student Administration Services at Politeknik Negeri Ujung Pandang

## **ABSTRACT**

The process of handling student correspondence submitted to the Study Program / Department, then processed by academics and signed by Deputy Director 1, has experienced obstacles in terms of the time needed to complete the various kinds of letters needed by students. Sometimes, it takes up to one week to complete the process. If a student sends a Professional Work Practice (PKP) application letter to the Industry and the letter is rejected, the student must repeat the process of proposing the application letter for a long time. This is because the correspondence process still uses conventional methods. This research aims to develop a web application that is integrated with various related units in handling student correspondence at Ujung Pandang State Polytechnic. The waterfall method is used in its development, including needs analysis, design, development, testing, and implementation. The result is an application that facilitates the management of student letter administration with a barcode system for verification and signing, ensuring efficiency and effectiveness in the process. The results of this research are as follows:

1) Assist the storage of data management of academic administration services; 2) The process of inputting statement letter data becomes easier and faster; 3) Make it easier for department/study program / related unit admins to manage statement letters; 4) searching for administrative service data and statement letters is easier and faster; 5) integrated student data and statement letters can improve the quality of administrative services at Politeknik Negeri Ujung Pandang.

#### 1. Introduction

Higher education as a center of education requires an effective and efficient information system to manage academic activities. This not only aims to increase efficiency but also to improve education quality standards (Suminten, 2021).

Students have various needs related to information and correspondence in their education (Widodo, 2018). However, research results show that many aspects of services in higher education, especially related to the use of student mail service administration systems, require improvement (Rizal, 2017).

Ujung Pandang State Polytechnic, as one of the Vocational Education colleges that has expertise in data processing and information needs, should adopt a technology-based information system that can support efficiency in student academic processes, including correspondence. Unfortunately, it is seen that in the Academic section, the Study Program / Department still uses conventional methods in the process of submitting Field Work Practice letters to industry, active college statement letters, research permits, and graduation certificates. This causes the procedure followed by students to apply for fieldwork research letters to still be relatively long.

For example, students must submit a request to the staff of the Study Program / Department, after which the letter must be signed by the Head of the Department, then forwarded to the Academic section for processing and obtaining the signature of the Deputy Director 1.

The foregoing can be proven through the results of research [Taufik, 2020] on academic services, which states that "The academic administration system in managing various kinds of correspondence needed by students, such as letters of Field Work Practice to industry, active college certificates, research permits, and graduation certificates, and completeness of Final Project Report exam files, and so on, received a 'less satisfied' level of satisfaction of 51.5%, on the grounds that it took quite a long time to complete.

By considering these aspects, this research aims to implement a Web Application for Student Correspondence Administration Services of the PNUP Commercial Administration Department that allows study program staff and academic staff who handle student correspondence to use their respective logins. That way, student correspondence administration services can be well integrated between the staff of each study program, department, and academic staff.

#### 2. Literature Review

Administrative services are a form of activity carried out by the government or public institutions in order to meet the needs of the community for administrative services [Hendrayady, 2022].

The correspondence system is a series of administrative actions to handle incoming letters, outgoing letters, memos, telegrams, and other archives in the sense of managing and arranging them correctly, efficiently, and effectively for the benefit of the organization and the public." (Nugroho, 2017)

Statement Letter is a letter given by universities to students as proof of their status as active students and contains information about the study period, study program, and student activeness status. Statement Letter is often requested as a requirement for administrative purposes, such as scholarships, course registration, and other purposes [Cahyono, 2016]. Furthermore, a statement letter is an official document issued by a higher education institution that contains information about the student's active status, the study program taken, and their academic achievements [Frengky, A, 2019].

The use of electronic media has become a necessity and solution in solving administrative process problems. Electronic media is expected to be able to help document managers with both effective and efficient [Imasita, 2022].

An application is a computer program created to meet certain user needs in performing specific tasks related to data processing. Applications can be used on various electronic devices, such as computers, smartphones, or tablets, and are designed to make it easier for users to perform certain tasks on these devices [Sri Tita, 2021].

The waterfall application development method is one approach to software development that involves stages that must be carried out sequentially and continuously. The stages in the waterfall method include requirements analysis, design, implementation, testing, and maintenance. This approach allows developers to see the big picture of the entire project and allows for better planning. However, this approach has a weakness, which is that it lacks flexibility in addressing changing user needs that arise during the development process [Sommvervile, 2016].




Fig. 1 Waterfall method

Website design is carried out using visualization of various diagrams to make it easier to build the system later so that the description made is clear in its intent and purpose.




Fig 2 Context Diagram




Fig 3 Flowchart of Statement letter Submission (left) and Verification of Statement Letter by Department and Study Program (right)




Fig 4 Flowchart of Verification of Statement Letter by academic (left) and Verification of Statement Letter by Deputy

Director 1 (right)




Fig 5 Application Database

This page appears after a successful log in process, which will then display the system homepage on the screen. Students can select and press the menu as needed.




Fig 7 Student Dashboard Page




Fig. 8 Page of Active College Statement Letter




Fig. 10 Research Permission Letter page

Student settings is a page that displays student data registered in the application.




Fig. 12 Student Settings Page

The admin system dashboard displays information about the total number of letters, the total letters that have not been processed, the total letters being checked and the total letters that have been completed.




Fig. 13 Letter Type Page




Fig. 15 Manage Department page




Fig. 19 Section Head User Management Page
